CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. W. RYAN

of Route 2, Box 600, Central Point, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean irrigation of 50.0 acres

for the purpose of

under Permit No. 19294 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 10, 1950,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.63 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE_{4}^{1} NN_{4}^{1} , Section 6, T. 36 S., R. 1 N., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

M., excepting therefrom that certain property described in Vol. 174 page 254; also excepting therefrom that certain property described in Vol. 107 page 348; also excepting therefrom that certain property described in Vol. 118 page 37, of the Deed Records of Jackson County, Oregon.

This certificate is issued to correct and supersede that certain water right certificate issued to R. W. Ryan on April 30, 1951, and recorded in State Record of Water Right Certificates, Vol. 14, page 19616, so as to correctly show primary irrigation of the lands described.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
