CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHARLES NITCHMAN

of Route 3, Box 284, Hillsboro, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed spring, an unnamed creek and reservoir constructed under Application No. R-32955, Permit No. R-2227 a tributary of McKay Creek for the purpose of domestic use of one family, fish culture, and irrigation of 0.3 acre

under Permit No. 26043 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 13, 1959,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.12 cubic foot per second, being 0.01 c.f.s. for domestic use from spring, and 0.01 c.f.s. for irrigation and 0.10 c.f.s. for fish culture from creek and reservoir,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 19, NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 30, both in T. 2 N., R. 2 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit number R-2227, and the use of water herein granted for fish culture is limited to the use of water available at the diversion point and said right is subordinate and inferior to all future appropriations on the unnamed spring and unnamed creek and their tributaries for domestic, municipal, irrigation and industrial use and for storage for such uses and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Fish culture, domestic and 0.3 acre NW $\frac{1}{4}$ NE $\frac{1}{4}$
Section 30
T. 2 N., R. 2 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
