that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 6.52 cubic feet per second during the period beginning April 15 and ending October 15 of each year, and the total quantity diverted during each period shall not exceed 821.7 acre feet.
