CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. A. Briggs & Son.

, State of Oregon

, has a right to the use of

the waters of Cottonwood Creek, Helfenstine Creek and Misman Creek

for the purpose of irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Iake County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 7, at page 233; that the priority of the right thereby confirmed dates from 1879 for Tract No. 1

1881 for Tract No. 2

1890 for Tract No. 3

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed three-fourths acre foot per acre during any 30-day period prior to Juhe 1st, and one-half acre foot per acre during any 30-day period after June 1st, of each year; and two and one-half acre feet per acre during any irrigation season; to be diverted under a head of not to exceed one-fortieth of a second foot per acre.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

NOTE: Certificate of water right issued to Jones & Lane and recorded at page 5204, Volume 6, State Record of Water Right Certificates, confirms a right to the use of water for irrigation and the development of power. Subsequently, the right for the development of power was canceled by order of the State Engineer entered February 20, 1964, pursuant to the provisions of ORS 543.730. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Jones and Lane.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
