CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRANK E. GILPATRICK

of Star Route, Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Powers Creek and unnamed spring

a tributary of Abiqua Creek for the purpose of irrigation and domestic use 1 house and cabin

under Permit No. 14800 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 13, 1941,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.20 cubic foot per second, being 0.01 c.f.s. from spring for domestic and 0.19 c.f.s. from Powers Creek for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ & NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 9, SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 10 T. 7 S., R. 1 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

12.1 acres SE $\frac{1}{2}$ NE $\frac{1}{4}$
7.9 acres and domestic NE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 9
Domestic in the NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 10
T. 7 S., R. 1 E., W. M.

Certificate of water right issued to Frank E. Gilpatrick and recorded at page 23394, Volume 16, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 40 acres and domestic. Subsequently, the right to the use of water appurtenant to 20 acres was transferred by order of the State Engineer entered February 4, 1964. This certificate is issued to confirm the remaining right to the use of water for irrigation and domestic and supercedes the certificate heretofore issued to Frank E. Gilpatrick.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
