**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** RODNEY CHASE

of 798 Royaldel Lane, Springfield, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two wells

a tributary of Willamette River for the purpose of irrigation of 100.8 acres

under Permit No. G-1618 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 15, 1960,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.26 cubic feet per second, being 0.43 c.f.s. from west well and 0.83 c.f.s. from east well

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  SW $\frac{1}{4}$ , NW $\frac{1}{4}$  SW $\frac{1}{4}$ , both as projected within Callison DIC 73, Sec. 15, T. 18 S., R. 2 W., W. M.; Wells located 550 ft. South and 2475 ft. East, & 500 ft. South and 1100 ft. East both from NW corner, DIC 73.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

19.6 acres NE $\frac{1}{4}$  SW $\frac{1}{4}$

29.6 acres NW $\frac{1}{4}$  SW $\frac{1}{4}$

12.0 acres SW $\frac{1}{4}$  SW $\frac{1}{4}$

16.0 acres SE $\frac{1}{4}$  SW $\frac{1}{4}$

Section 15

23.6 acres NE $\frac{1}{4}$  SE $\frac{1}{4}$

Section 16

all as projected within Callison DIC 73  
T. 18 S., R. 2 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
