**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That BEN E. WOOD**

of Arago Route, Box 13, Myrtle Point, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coquille River

a tributary of Pacific Ocean  
irrigation of 82.8 acres

for the purpose of

under Permit No. 24215 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 20, 1956,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.75 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 10 (NE $\frac{1}{4}$  SW $\frac{1}{4}$ ), Section 31, T. 28 S., R. 12 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-eightieth~~ of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall  
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.2 acres Lot 10 (NE $\frac{1}{4}$  SW $\frac{1}{4}$ )  
2.8 acres Lot 11 (NW $\frac{1}{4}$  SW $\frac{1}{4}$ )  
25.0 acres Lot 11 (SW $\frac{1}{4}$  SW $\frac{1}{4}$ )  
24.2 acres Lot 10 (SE $\frac{1}{4}$  SW $\frac{1}{4}$ )  
Section 31  
T. 28 S., R. 12 W., W. M.  
6.0 acres NE $\frac{1}{4}$  NW $\frac{1}{4}$   
21.6 acres NW $\frac{1}{4}$  NW $\frac{1}{4}$   
Section 6  
T. 29 S., R. 12 W., W. M.

This certificate is issued to correct and supersede that certain water right certificate issued to Ben E. Wood on September 13, 1962, and recorded in State Record of Water Right Certificates, Volume 22, page 30064, so as to correctly show the correct townships for Sections 6 and 31.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
