CERTIFICATE OF WATER RIGHT

This Is to Certify. That LLOYD E. RING

of 2855 Favill Road, Grants Pass , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean irrigation of 0.3 acre

for the purpose of

under Permit No. 27862 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 19, 1962,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (SW 1 W 1), Section 22, T. 36 S., R. 5 W.,

Th, amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acrept its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of the Rogue River is more than 735 c.f.s. at its mouth,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 0.3 acre Lot 4 (SW 1 NW 1) Section 22 T. 36 S., R. 5 W., W. M.

Land on which water is to be used is part of that described as follows:

Commencing at the Northeast corner of Lot 4 in Section 23, Township 36 South, Range 5 West of the Willamette Meridian, Josephine County, Oregon, and thence West 8.9 chains; thence South 0 41' 56" West to the North bank of Rogue River, which is the true point of beginning, said point being the Southeast corner of a tract conveyed by Instrument No. 83173, Josephine County, Deed Records; thence North O' 41' 56" East 150 feet; thence East 100 feet; thence South 0° 41' 56" West 150 feet more or less, to the North bank of Rogue River; thence Westerly along said North bank of Rogue River 100 feet, more or less, to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
