**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** NILS B. HULT

of Bailey Hill Road, Route 3, Eugene, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Amazon Slough  
irrigation

for the purpose of

under Permit No. G-830 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 10, 1958,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within Lindley DIC 42, Sec. 3, T. 18 S., R. 4 W., W. M., Well located 275 feet North and 1025 feet East of SW corner, DIC 42.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.4 acres NW $\frac{1}{4}$  SE $\frac{1}{4}$   
as projected within Lindley DIC 42  
Section 3  
T. 18 S., R. 4 W., W. M.

Land on which water is to be used is part of that described as follows:

Beginning at SW corner of Lot 4, Block 4 in the plat of Cherry Lands, and running thence S. 0° 39' E. 718.12 feet, thence S. 85° 02' W. 171.15 feet, thence N. 0° 18' E. 228.4 feet, thence N. 76° 39' 20" W. 716.18 feet, thence N. 3° 22' W. 697.5 feet, thence S. 87° 12' E. 76.2 feet, thence N. 2° 35' W. 307.02 feet, thence N. 89° 14' E. 213.94 feet, thence S. 1° 8' E. 103.5 feet, thence N. 67° 57' E. 313.3 feet, thence S. 1° 8' E. 31.7 feet, thence N. 88° 22' E. 322.4 feet to a point 0.63 feet N. 0° 39' W. of the NW corner of Lot 4, Block 4 of said plat of Cherry Lands, thence S. 0° 39' E. 654.63 feet to place of beginning

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
