CERTIFICATE OF WATER RIGHT

This Is to Certify, That H. W. HAYNES

of Route 1, Box 244 C, Junction City, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Long Tom River

a tributary of Willamette River
irrigation

for the purpose of

under Permit No. 25568 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 9, 1958,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Brown DLC 38, Sec. 4, T. 17 S., R. 5 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

30.2 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
as projected within Brown DLC 38
Section 4
T. 17 S., R. 5 W., W. M.

Land on which water is to be used is to be used is part of that described as follows:

Beginning at the southwest corner of the Brown DLC No. 38 in Township 17 South, Range 5 West of the W. M., and running thence North 8° 30' west along the West line of said claim 18.47 chains to a point 2.53 chains South 8° 30' East of the North line of Section 4, said Township and Range, thence South 89° 41' East 38.90 chains to a point 2.50 chains due South of the quarter section corner on North line of Section 4, thence North 83° 25' East 19.93 chains to the intersection of the East line of said DLC with the north line of Section 4, thence South 20.68 chains to the Southeast corner of said DLC, thence West 55.70 chains to the place of beginning in Lane County, Oregon

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
