## CERTIFICATE OF WATER RIGHT

This Is to Certify, That CARROL D. PARKINSON, M. D.

of 2131 McMillian Street, Eugene , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Fern Ridge Reservoir constructed under Permit No. R-1625

a tributary of Long Tom River irrigation of 7.3 acres

for the purpose of

under Permit No. 25765 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 16, 1958,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 15.7 acre feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SW_4^1$   $SW_4^1$ , as projected within Lasater DIC 44, Sec. 8, T. 17 S., R. 5 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to \_\_\_\_\_\_ of one cubic foot per second per acre, a diversion of  $2\frac{1}{2}$  acre feet per acre or its equivalent for each acre irrigated during the irrigation season of each year and shall be further limited to a total diversion of not to exceed 15.7 acre feet per year; and is subject to the terms of contract No. 14-06-100-1563 between the Bureau of Reclamation and Carrol D. Parkinson,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is

appurtenant, is as follows:

S. Army Engineer Monument No. W-151, thence N. 70° 58' E. on a line between U. S. Army Engineer Monuments No. W-151 and No. V-151, 568.57 ft. to the North line of the above mentioned claim, thence run along said North line of said claim N. 87° 42' W. 1815.17 ft. to the point of beginning with the control of the water for the purposes aforesaid is restricted to the lands or place of use herein-described.
