CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRED VIESKO

of Route 1, Box 105, Gervais, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Willamette River for the purpose of irrigation of 67.5 acres

under Permit No. G-511 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 22, 1957,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.84 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (SW $\frac{1}{4}$ NE $\frac{1}{4}$), Section 35, T. 5 S., R. 3 W., W. M.; Well located 1814.8 feet North and 2974.1 feet East from most Northerly NE corner, Matheny DIC 76.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

19.6 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Gervais DIC 69
5.0 acres Lot 5 (SW $\frac{1}{4}$ NE $\frac{1}{4}$)
9.4 acres SW $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Gervais DIC 69
3.1 acres Lot 2 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)
4.0 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Gervais DIC 69
0.9 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
22.3 acres Lot 4 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)
3.2 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Gervais DIC 69
Section 35
T. 5 S., R. 3 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
