## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** JOHNNY Y. WAKAMATSU

of Route 3, Box 586, Hood River, State of Oregon, has a right to the use of the waters of spring and brook, tributary of Indian Creek & Indian Creek

a tributary of Hood River for the purpose of irrigation of 9.7 acres & domestic for Tr. 1 & irrigation of 16.0 acres for Tr. 2 and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Hood River County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 6, at page 200; that the priority of the right thereby confirmed dates from May 1884 for Tract 1, & 1898 for Tract 2

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-eightieth of one cubic foot per second or its equivalent in case of rotation, and that the total quantity diverted during the irrigation season shall not exceed 3 acre feet per acre measured at the point of diversion.

The point of diversion is located in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 17, T. 2 N., R. 10 E., W. M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the State Engineer entered September 6, 1960, and supersedes certificate of water right heretofore issued to Rosa M. Crapper and recorded at page 14950, Volume 12, State Record of Water Right Certificates.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
