## CERTIFICATE OF WATER RIGHT

**This Is to Certify,** *A. T. and K. ETHEL LATHROP*  
*That & JAMES L. and NAOMI L. LATHROP*

of 1700 Cave Camp Road, Williams, State of <sup>97544</sup> Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of West Fork Williams Creek

a tributary of Williams Creek  
 irrigation of 34.5 acres

for the purpose of

under Permit No. 17159 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 17, 1946,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.43 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 8, T. 39 S., R. 5 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $4\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31, of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.0 acres SW $\frac{1}{4}$  SW $\frac{1}{4}$   
 19.5 acres SE $\frac{1}{4}$  SW $\frac{1}{4}$   
 2.0 acres SW $\frac{1}{4}$  SE $\frac{1}{4}$

 T. 39 S., R. 5 W., W. M.

Certificate of water right issued to James L. Lathrop and recorded at page 19777, Volume 14, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 40 acres. Subsequently, the right to the use of water appurtenant to 5.5 acres was canceled by order of the State Engineer entered June 4, 1964. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to James L. Lathrop.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
