CERTIFICATE OF WATER RIGHT

This Is to Certify, That LEE SHRODE

of Williams, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed creek

a tributary of West Fork Williams Creek for the purpose of irrigation and supplemental irrigation of 11.0 acres

under Permit No. 18501 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 24, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.14 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 5, Township 39 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.0 acres primary in SW $\frac{1}{4}$ SW $\frac{1}{4}$
4.0 acres supplemental in SW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 5
Township 39 South, Range 5 West, W. M.

Certificate of water right issued to Lee Shrode and recorded at page 19572, Volume 14, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 7.0 acres and supplemental irrigation of 10.0 acres. Subsequently, the right to the use of water appurtenant to 6 acres for supplemental irrigation was transferred by order of the State Engineer dated August 13, 1964. This certificate is issued to confirm the remaining right to the use of water for irrigation and supplemental irrigation and supersedes the certificate heretofore issued to Lee Shrode.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
