CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOSEPH C. and RIEANOR STADLER

of Box 83 A Kellogg Star Route, Oakland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Umpqua River

a tributary of Pacific Ocean irrigation of h.5 acres

for the purpose of

under Permit No. 27924 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 6, 1960

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NE4 SE4), Section 3, T. 24 S., R. 7 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow in the Umpqua River is more than 525 c.f.s. at tidewater,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is part of that described as follows:

Beginning at a point on the North side of County Road 57 from which the corner common to Sections 2, 3, 10, 11, T. 24 S., R. 7 W., W. M., bears South 81° 48° East 326.28 feet and South 592.87 feet and East 181.5 feet, said point being the southwesterly corner of that tract conveyed to Paul G. Athey & wife; thence North along the West line of said Athey tract, 724 feet; thence continuing North 26 feet to point in the South side of the Umpqua River; thence North 65° 07° West 309.74 feet to point; thence South 26.2 feet to point; thence continuing South 773.8 feet to point in the North line of said County Road; thence South 74° 03° East along the North line of said road 292.44 feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
