Wallowa County, and the said decree entered of record at Salem, in the Order

Record of the State Water Board of the State of Oregon, in Volume 5 , at page s 202-203;

that the priority of the right hereby confirmed dates from 1894 for Tract No. 1; 1895 for Tract No. 2: 1896 for Tract No. 3 and 1885 for Tract No. 4

that the amount of water to which such right is entitled and hereby confirmed for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-eightieth of one cubic foot per second per acre; and said rights shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: Tract No. 1: 15 acres in the NE¹/₄NE¹/₄ and 40 acres in the NW¹/₄NE¹/₄ of Section 10, Township 3 South, Range 45 East of Willamette Meridian, in Wallowa County, Oregon.

Tract No. 2: 10 acres in the $NE_{\pm}^{1}NE_{\pm}^{1}$ of Section 10, Township 3 South, Range 45 East of Willamette Meridian, in Wallowa County, Oregon.

Tract No. 3: 6 acres in the $NE_2^1NE_4^1$ of Section 10 and 4 acres in the $NW_4^1NW_4^1$ of Section 11, Township 3 South, Range 45 East of Willamette Meridian, in Wallowa County, Oregon.

Tract No. 4: 6 acres in the $NW_4^1NW_4^1$ of Section 11, Township 3 South, Range 45 East of Willamette Meridian, in Wallowa County, Oregon.

Part of lands under tract 1/0's 3+4 Transferred. See Sp Or. Yol, 2p 91.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
