Record of the State Water Board of the State of Oregon, in Volume 5 . at page 206 ; that the priority of the right hereby confirmed dates from May 7, 1884

that the amount of water to which such right is entitled and hereby confirmed for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 12 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree under such right, and to which the water hereby con-

firmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use,

is as follows: 30 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ and 40 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 15: $2\frac{1}{2}$ acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$; 37 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$; 40 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ and 23 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 14: 27 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ and 25 acres in the SWANE of Section 22 and 30 acres in the NWANW of Section 23, Township 1 North, Range 4 2 East of Willamette Meridian, in Wallows County, Oregon.
