CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, That the WRENN & DOBBIN DITCH COMPANY, a corporation, by A. W. Schaupp, of Joseph, State of Oregon, has a right to the use of the waters of the Wallowa River, a tributary of the Grande Ronde River, for the purpose of the irrigation of 2,760.75 acres of land, domestic and stock use, and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of Oregon, in Volume 5, at pages 206, 207 and 208; that the priority of the right hereby confirmed dates from September 10, 1901; that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1 1/2 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

Tract No. 1: 40 acres in the NE 1/4 NW 1/4; 13 acres in the NW 1/4 NW 1/4; 14 acres in the SW 1/4 NW 1/4 and 40 acres in the SE 1/4 NW 1/4 of Section 18, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 2: 2 acres in the NE 1/4 NW 1/4 and 25 acres in the NW 1/4 NW 1/4 of Section 7, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 3: 10 acres in the NE 1/4 NE 1/4; 30 acres in the NW 1/4 NE 1/4; 40 acres in the SW 1/4 NE 1/4; 40 acres in the SE 1/4 NE 1/4; 40 acres in the NE 1/4 SE 1/4; 40 acres in the NW 1/4 SE 1/4; 40 acres in the SW 1/4 SE 1/4 and 40 acres in the SE 1/4 SE 1/4 of Section 8: 30 acres in the NE 1/4 SW 1/4; 40 acres in the NW 1/4 SW 1/4; 40 acres in the SW 1/4 SW 1/4; 40 acres in the SE 1/4 SW 1/4; 10 acres in the NW 1/4 SE 1/4 and 20 acres in the SW 1/4 SE 1/4 of Section 9: 40 acres in the NE 1/4 NE 1/4; 35 acres in the NW 1/4 NE 1/4; 30 acres in the SE 1/4 NE 1/4 and 9 acres in the NE 1/4 NW 1/4 of Section 17: 40 acres in the NW 1/4 NE 1/4; 40 acres in the NE 1/4 NW 1/4 and 40 acres in the NW 1/4 NW 1/4 of Section 16, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 4: 6 1/2 acres in the SW 1/4 NW 1/4; 40 acres in the SE 1/4 NW 1/4; 40 acres in the SW 1/4 NE 1/4 and 40 acres in the SE 1/4 NE 1/4 of Section 19, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 5: 40 acres in the SE 1/4 NW 1/4; 40 acres in the NE 1/4 SW 1/4; 40 acres in the SE 1/4 SW 1/4; 40 acres in the SW 1/4 SE 1/4 and 40 acres in the SE 1/4 SE 1/4 of Section 16, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 6: 16 acres in the SW 1/4 SW 1/4; 40 acres in the SE 1/4 SW 1/4; 37 acres in the SW 1/4 SE 1/4 and 40 acres in the SE 1/4 SE 1/4 of Section 18, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 7: 35 acres in the NE 1/4 SW 1/4; 40 acres in the NW 1/4 SW 1/4; 30 acres in the SW 1/4 SW 1/4 and 10 acres in the SE 1/4 SW 1/4 of Section 21, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 8: 40 acres in the NE 1/4 NW 1/4; 40 acres in the NW 1/4 NW 1/4 and 40 acres in the SW 1/4 NW 1/4 of Section 21, Township 2 South, Range 45 East of Willamette Meridian. 25 acres in the NE 1/4 NE 1/4; 40 acres in the NW 1/4 NE 1/4; 30 acres in the SW 1/4 NE 1/4 and 3 acres in the SE 1/4 NE 1/4 of Section 21, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 9: 40 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ ; 40 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$  and 40 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 16, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 10: 6 $\frac{1}{2}$  acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 30, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 11: 40 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ ; 25 acres in the S $\frac{1}{4}$ NW $\frac{1}{4}$ ; 38 $\frac{1}{2}$  acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$  and 18 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 7, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 12; 40 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ ; 40 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ ; 20 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$  and 30 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 29, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 13: 20 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ ; 40 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$  and 5 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 29, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 14: 40 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$  and 40 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 20, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 15: 40 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ ; 40 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ ; 40 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$  and 40 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 16, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 16: 38 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ ; 36 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ ; 40 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$  and 12 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 19, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 17: 40 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$  and 40 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 30, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 18: 40 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ ; 37 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ ; 40 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$  and 12 acres in the S $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 30, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 19: 40 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ ; 2 $\frac{1}{2}$  acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ ; 40 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$  and 40 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 19, Township 2 South, Range 45 East of Willamette Meridian.

All of the above described lands being in Wallowa County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
