CERTIFICATE OF WATER RIGHT

(For rights perfected under State Engineer's permits)

This is to Certify, That SNAKE RIVER DISTRICT IMPROVEMENT COMPANY

of Weiser, State of Idaho, has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Snake River, a tributary of

for the purpose of the irrigation of 2208 acres of land under Permit No. 1380 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1, at page 389, on the 13th day of April, 1921; that the priority of the right hereby confirmed dates from November 25, 1912; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 27.60 cubic feet per second, or its equivalent in case of rotation. The use hereunder shall conform to any reasonable rotation system ordered by the proper State Officer.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
