CERTIFICATE OF WATER RIGHT

This Is to Certify. That CHET I.

CHET I. & DORATHY S. NELSON

of Route 3, Salem, , State of Oregon, , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Thistledew Spring

a tributary of Croisan Creek (Willamette River) irrigation

for the purpose of

under Perm't No. 5630 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed cates from September 18, 1922

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount octually beneficially used for said purposes, and shall not exceed 0.0h cubic frot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the \mathbb{N}_{4} Ne $_{4}$ Section 8, T. 8 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.7 acres NE¹/₄ NE¹/₄ 0.5 acre NW¹/₄ NE¹/₄ Section 8 T. 8 S., R. 3 W., W. M.

Landon which water is used is part of that described as follows: Lots 13 and 14, Sunnyside Fruit Farms.

Certificate of water right issued to Mrs. Viola B. Matheson and recorded at page 6675, Volume 7, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 6.0 acres. Subsequently, the right to the use of water appurtenant to 2.8 acres was cancelled by order of the State Engineer entered December 14, 1964. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Chet I. & Dorathy S. Nelson.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
