that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 12.2 cubic feet per second, being 1.00 c.f.s. from well #3, 1.80 c.f.s. from well #6, 3.60 c.f.s. from well #7, and 5.80 c.f.s. from well #8

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 8 (SN N NN SEL NN), Section 32, T. 38 S., R. 9 E., N. M. Wells located: #3, 2215 feet S. & 1160 feet E.; #6, 2215 feet S. and 1320 feet E.; #7, 2080 feet S. and 1128 feet E.; #8, 2260 feet S.(cont.)

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to of one cubic foot per second per acre,
