CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROBERT F. MARQUESS

of Route 2, Box 218, Creswell , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a spring, unnamed stream and the Coast Fork of Willamette River

a tributary of Willamette River for the purpose of domestic use of one family and irrigation of 103.4 acres

under Permit No. 27787 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 7, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.82 cubic foot per second; being 0.01 c.f.s. from spring; 0.05 c.f.s. from unnamed stream and 0.76 c.f.s. from Coast Fork Willamette River

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 8 (NE $\frac{1}{4}$ SW $\frac{1}{4}$), Lot 4 (SW $\frac{1}{4}$ SE $\frac{1}{4}$), Lot 5 (SE $\frac{1}{4}$ SW $\frac{1}{4}$) and Lot 12 (NE $\frac{1}{4}$ SE $\frac{1}{4}$) all in section 24, T. 19 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be further limited to the period when the flow of the Coast Fork Willamette River is more than 135 c.f.s. at its mouth;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
