## CERTIFICATE OF WATER RIGHT

This Is to Certify, That GEO. W. ELMS and SIDNEY ELMS

of Unity, State of Oregon, has a right to the use of the waters of S. Fork Burnt River

a tributary of \_\_\_\_\_ for the purpose of irrigation of 288.5 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8, at page 134; that the priority of the right thereby confirmed dates from August, 1888

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.0 acre feet per acre during any irrigation season (with the further limitations contained in Paragraph 64 of said decree);

Certificate of water right issued to Geo. W. & Sidney Elms and recorded at page 5885, Volume 6, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 317 acres. Subsequently, the right to the use of water appurtenant to 28.5 acres was transferred by order of the State Engineer entered February 16, 1965. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Geo. W. & Sidney Elms.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
