CERTIFICATE OF WATER RIGHT

This Is to Certify, That ESTATE OF WM. J. GALBRAITHBy Marian E. Galbraith, Administrix
of Prairie City , State of Oregon , has a right
to the use of the waters of John Day Rivera tributary of Columbia River for the purpose of
irrigation of 179.2 acres
and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Grant County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 15 , at page 461 ; that the priority of the right thereby
confirmed dates from 1874that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 1/40 cubic foot per
second per acre irrigated from April 1 to Sept. 30; further limited to one acre-
foot per acre per calendar month to July 1 and 3/4 acre foot per acre thereafter;
total five acre feet per acre for season, measured at point of diversion.

T. 13 S., R. 33 E., W. M.Certificate of water right issued to Estate of Wm. J. Galbraith and recorded at
page 25211, Volume 17, State Record of Water Right Certificates, confirms a
right to the use of water for irrigation of 220 acres. Subsequently, the point
of diversion for the right to the use of water appurtenant to 40.8 acres was
transferred by order of the State Engineer entered March 15, 1965. This cer-
tificate is issued to confirm the remaining right to the use of water for irri-
gation and supersedes the certificate heretofore issued to Estate of Wm. J.
Galbraith.And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place
of use herein described.
