Route 1, Box 336, Eagle Point , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Spring and side channel of Rogue River

atributary of Pacific Ocean fort irrigation of 75.1 acres and domestic use of four families and stock Pacific Ocean for the purpose of

26751 of the State Engineer, and that said right to the use of said waters under Permit No. has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Hay 3, 1960

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.93 cubic foot per second; being 0.91 c.f.s. from Rogue River for irrigation, 0.01 c.f.s. from spring for domestic use and 0.01 c.f.s. from spring for stock

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the [135] UE; of Section 29 and Lot 5 (SE 34), Section 20, T. 35 S., R. 1 J., J. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed he acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of the Rogue hiver is more than 1000 c.f.s. at Raygold, more than 1000 c.f.s. immediately above Savage Rapids Dam and more than 735 c.f.s. at its mouth;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
