CERTIFICATE OF WATER RIGHT

This Is to Certify, That AUGUST B. & VIVIAN CLARK

of Rt. 1, Box 120 Gold Hill, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean for the purpose of irrigation of 1.4 acres

under Permit No. 28268 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 21, 1961.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (SE $\frac{1}{4}$ SW $\frac{1}{4}$) Section 17, T. 36 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right to use of water is limited to the period when the flow of the Rogue River is more than 1000 c.f.s. immediately above Savage Rapids Dam and more than 735 c.f.s. at its mouth;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acres Lot 3 (SE $\frac{1}{4}$ SW $\frac{1}{4}$)
Section 17
T. 36 S., R. 3 W., W. M.

Land on which water is to be used is described as follows:

Beginning at the Quarter Section corner on the South line of Section 17 in Township 36 South, Range 3 West of the Willamette Meridian in Jackson County, Oregon; thence West on the Section line 160.0 feet; thence North 520.0 feet to Rogue River; thence along said River, North 74° 37' East 165.9 feet to the East line of Lot 3 in said Section 17; thence South 564.0 feet to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
