CERTIFICATE OF WATER RIGHT

This Is to Certify. That W. V. CHAMBERLIN AND VIVIAN M. CHAMBERLIN

of Route 1, Marion , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Santiam River

a tributary of Santiam River irrigation of 13.1 acres

for the purpose of

under Permit No. 17435 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priorit; of the right hereby confirmed dates from December 16, 1946

that the amount of water to which such right is intitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.16 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 ($\mathbb{N}^{\frac{1}{4}}$ $\mathbb{N}^{\frac{1}{4}}$) and Lot 2 ($\mathbb{SE}^{\frac{1}{4}}_{4}$ $\mathbb{N}^{\frac{1}{4}}$), Section 35, T. 9 S., R. 2 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotatic: system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Certificate of water right issued to W. V. Chamberlin and recorded at page 21381, Volume 15, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 28.0 acres. Subsequently, the right to the use of water appurtenant to 14.9 acres was canceled by order of the State Engineer entered June 23, 1965. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to W. V. Chamberlin and Vivian M. Chamberlin.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
