CERTIFICATE OF WATER RIGHT

This Is to Certify, That RALPH P. AND BERTHA M. HOWE

of P. O. Box 376, Dallas, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rickreall Creek

a tributary of Willamette River for the purpose of domestic use of one family, including irrigation of not to exceed $\frac{1}{2}$ acre lawn and garden under Permit No. 29141 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 21, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (SE $\frac{1}{4}$ NW $\frac{1}{4}$), Section 36, T. 7 S., R. 6 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is further described as follows:

Beginning at a point 90.0 feet N. 0°30' W. from the Southwest corner of Tract 1, Lauterman's LaCreole Summer Home Tracts, in Section 36, Township 7 South, Range 6 West of the Willamette Meridian, in Polk County, Oregon; and running thence N. 0°30' W. 3.0 feet; thence N. 32°30' W. 180.0 feet; thence N. 6°38' W. 34.34 feet; thence N. 89°30' E. 225.87 feet to an iron pipe on the West line of the County Road; thence along the arc of a 409.3 foot radius curve (the long chord of which bears S. 21°17' E. 87.7 feet) to an iron pipe; thence S. 27°24' E. 121.21 feet to an iron pipe; thence S. 89°30' W. 212.74 feet to the place of beginning, and containing 0.943 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
