CERTIFICATE OF WATER RIGHT

This Is to Certify, That CURTIS TRENT

of Route 2, Box 672, Roseburg, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Umpqua River

a tributary of Umpqua River
irrigation of 11.0 acres

for the purpose of

under Permit No. 28229 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 31, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.14 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within McKinney DLC 47, Section 22, T. 26 S., R. 6 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of the North Umpqua River is more than 525 c.f.s. at its mouth,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$
as projected within McKinney DLC 47
Section 22
1.6 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$
as projected within McKinney DLC 47
Section 23
1.6 acres NW $\frac{1}{4}$ NW $\frac{1}{4}$
as projected within McKinney DLC 47
Section 26
6.4 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
as projected within McKinney DLC 47
Section 27
T. 26 S., R. 6 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
