CERTIFICATE OF WATER RIGHT

This Is to Certify, That EARL & HAZEL WEATHERS

of Route 2, Box 77, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Hubbard Lake

a tributary of Willamette River for the purpose of irrigation of 22.5 acres

under Permit No. 23736 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 30, 1955

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 36, T. 5 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.0 acres Lot 4 (SW $\frac{1}{4}$ NW $\frac{1}{4}$)
4.0 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
12.5 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 36
T. 5 S., R. 3 W., W. M.

The certificate recorded at page 28928, Volume 21, State Record of Water Right Certificates, issued to Mission Bottom Hop Company, confirmed a right for the irrigation of 95.73 acres. Subsequently, the right for the irrigation of 68.68 acres was canceled by Order of the State Engineer entered April 8, 1964. This certificate is issued to confirm a change in place of use and point of diversion and approved by an Order of the State Engineer entered April 9, 1964, and supersedes the certificate heretofore issued to Mission Bottom Hop Company.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
