CERTIFICATE OF WATER RIGHT

This Is to Certify, That RALPH N. and WINONA WILSON,

of Central Point, State of Oregon, has a right
to the use of the waters of Rogue River

a tributary of Pacific Ocean for the purpose of
domestic, stock and irrigation of 68.6 acres
and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Jackson County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 16, at page 523; that the priority of the right thereby
confirmed dates from September 22, 1888;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 0.86 cubic foot per
second.

The point of diversion is located in the Lot 7 (NE $\frac{1}{4}$ NW $\frac{1}{4}$) Section 6, T. 36 S., R. 1 W., W.M.

A description of the place of use under the right, and to which such right is appurtenant, is as
follows:

35.8 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$

29.4 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
3.4 acres SW $\frac{1}{4}$ NE $\frac{1}{4}$

described as follows:

The East half of the following-described land: Beginning at the SW corner of
D.L.C. 40 and running thence West to the East line of D.L.C. 43; thence South
to the SE corner of D.L.C. 43; thence with meanders of Rogue River up-stream
to a post on the right bank from which a maple 15 inches in diameter bears
South 86° East 28 links and an ash 15 inches in diameter bears North 36° West
79 links; thence North to a post from which a yellow pine 22 inches in diameter
bears North 1° East 164 links; thence West 5.90 chains to the place of beginning,
containing 155 acres, more or less, all in Sections 10 and 15, T. 36 S., R. 2 W.,
W.M., excepting from the above-described land the one-acre lot deeded to the
Table Rock School District and also excepting the 54 acres deeded to S. K. Adams,
as shown in 54-334, Deed Records, Jackson County, Oregon.

Also including the following-described tract: Beginning at a point on the North
bank of Rogue River 58.71 chains, more or less, South of the NW corner of
Government Lot 7 in Section 10, T. 36 S., R. 2 W., W.M.; thence North 58.71
chains, more or less, to the NW corner of said Lot 7; thence West 9.36 chains;
thence South 58.71 chains, more or less, to the North bank of Rogue River;
thence Easterly, following the present meanderings of the North bank of said
river 10 chains, more or less, to the place of beginning, containing 54.94
acres of land, excepting therefrom, however, the one-acre deeded off the NE
corner of said described tract for school purposes; also excepting the road
and ditch across the North end of said tract.

use herein described.
