and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 16, at page 523; that the priority of the right thereby confirmed dates from 1902;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.36 cubic foot per second.

The point of diversion is located in the NE+ NW+, Section 4, T. 36 S., R. 4 W., W.M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

4.8 acres in NE² NE¹ NE¹ 1.5 acres in NW¹ NE¹ NE¹ 2.5 acres in SW¹ NE¹ NE¹ 12.5 acres in SE¹ NE¹ all lying below the Old Mill Ditch, Section 9.

all of which are in that part of the following-described land, to-wit:

Commencing at the section corner common to Sections 3,4,9, and 10, T. 36 S., R. 4 W., W.M., Jackson County, Oregon; thence South 0° 25' East along the section line common to Sections 9 and 10, 776.16 feet; thence South 75° 30' West 462.0 feet to the true point of beginning; thence running South 24° 57' East 602.2 feet; thence South 0° 25' East 248.6 feet; thence East 198.0 feet to the section line; thence South 0° 25' East along said section line 162.0 feet (to a point from which the quarter section corner common to Sections 9 and 10 tears South 0° 25' East 793.3 feet); thence South 75° 30' West 7,960 feet; thence North 10° 00' West 207.5 feet; thence South 76° 00' West 1,893 feet, more or less, to the North and South center line of Section 9; thence North along said center line 841.0 feet; thence North 75° 30' East 2,265.0 feet, more or less, to the point of beginning.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
