CERTIFICATE OF WATER RIGHT

This Is to Certify, That **CALLIE R. HILL,**

of **Murphy**, State of **Oregon**, has a right
to the use of the waters of **Applegate River**

a tributary of **Rogue River** for the purpose of
domestic and irrigation of **87.6 acres**
and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Jackson County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume **16**, at page **523**; that the priority of the right thereby
confirmed dates from **October, 1898**;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed **1.75 cubic feet per**
second.

The point of diversion is located in the **SW $\frac{1}{4}$ SE $\frac{1}{4}$** , Section 17, T. 38 S., R. 4 W., W.M.

A description of the place of use under the right, and to which such right is appurtenant, is as
follows:

19.2 acres in **NW $\frac{1}{4}$ SW $\frac{1}{4}$**
Section 7,

13.1 acres in **SW $\frac{1}{4}$ NW $\frac{1}{4}$**
22.3 acres in **SE $\frac{1}{4}$ NW $\frac{1}{4}$**
Section 7,

all being within the following-described
tract:

Beginning at the SE corner of **NW $\frac{1}{4}$** , Section 7; running thence West **118.94** rods;
thence North **53.808** rods; thence East **118.94** rods to the quarter section line
of said Section 7; thence South **53.808** rods to the place of beginning.

10.0 acres in **NE $\frac{1}{4}$ NW $\frac{1}{4}$**
12.0 acres in **NW $\frac{1}{4}$ NW $\frac{1}{4}$**
6.0 acres in **SW $\frac{1}{4}$ NW $\frac{1}{4}$**
5.0 acres in **SE $\frac{1}{4}$ NW $\frac{1}{4}$**

all being within the following-described
tract:

running thence West **118.94** rods; thence South **106.92** rods; thence East **118.94** rods;
thence North **106.92** rods to the point of beginning.
