## CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. J. HOPPER,

of R.F.D. No. 3, Grants Pass, State of Oregon, has a right to the use of the waters of Applegate River

a tributary of Rogue River for the purpose of irrigation of 16.5 acres and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 16, at page 523; that the priority of the right thereby confirmed dates from 1902;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second.

The point of diversion is located in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 19, T. 37 S., R. 5 W., W.M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

9.5 acres in that part of NE $\frac{1}{4}$  NW $\frac{1}{4}$   
Section 24,  
described as follows:

Beginning at a point in the middle of the county road on the North line of Sec. 24, T. 37 S., R. 6 W., W.M., 131 ft. East of the NW cor. of the NE $\frac{1}{4}$  NW $\frac{1}{4}$  of said section; running thence in a Southeasterly direction along the middle of said county road a distance of 1250 ft.; thence Northeasterly 395 ft. to a point on the line between the NW $\frac{1}{4}$  and NE $\frac{1}{4}$  of said section a distance of 542 ft. from the North line of said section; thence North 542 ft. to the North line of said section; thence West along said North line 1189 ft. to the place of beginning, containing 13 acres, more or less.

1.0 acre in that part of NE $\frac{1}{4}$  NW $\frac{1}{4}$   
Section 24,  
described as follows:

Beginning at the SE cor. of the NW $\frac{1}{4}$  NE $\frac{1}{4}$  NW $\frac{1}{4}$  of Sec. 24, T. 37 S., R. 6 W., W.M.; thence East 240 ft. to the middle of the county road; thence Northwesterly along the middle of the county road to a point where said road intersects the North and South line between the NW $\frac{1}{4}$  NE $\frac{1}{4}$  NW $\frac{1}{4}$  and NE $\frac{1}{4}$  NE $\frac{1}{4}$  NW $\frac{1}{4}$  of said section; thence South to the place of beginning containing one acre, more or less.

6.0 acres being the South 6 acres of the SW $\frac{1}{4}$  NE $\frac{1}{4}$  NW $\frac{1}{4}$   
Section 24,  
T. 37 S., R. 6 W., W.M.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
