CERTIFICATE OF WATER RIGHT

This Is to Certify, That **WILLIAM F. SPRATLING, THOMAS A. WELLS and EUNICE M. SMITH, successors in interest to J. L. Helms,**

of 3246 Helms Road, Grants Pass, State of Oregon, has a right to the use of the waters of Applegate River

a tributary of Rogue River for the purpose of irrigation of 156.8 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 16, at page 523; that the priority of the right thereby confirmed dates from February, 1897;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.14 cubic feet per second.

The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 5, T. 37 S., R. 6 W., W.M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

18.0 acres in SW $\frac{1}{4}$ NE $\frac{1}{4}$

CERTIFICATE OF WATER RIGHT

This Is to Certify, That K. M. G. and ADA LOUISE NEILL,

of Ardenraig, Grants Pass, State of Oregon, has a right to the use of the waters of Applegate River

a tributary of Rogue River for the purpose of irrigation of 4.7 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 16, at page 523; that the priority of the right thereby confirmed dates from February, 1897;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.09 cubic foot per second.

The point of diversion is located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 8, T. 37 S., R. 6 W., W.M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

3.5 acres in SW $\frac{1}{4}$ NE $\frac{1}{4}$

1.2 acres in SE $\frac{1}{4}$ NE $\frac{1}{4}$

all in that part of S $\frac{1}{2}$ NE $\frac{1}{4}$,

Section 31, lying North of

the following-described

line:

Beginning at a point 1682 feet South of the N $\frac{1}{4}$ corner of said Section 31; thence South 45° 21' East 222.7 feet; thence South 61° 14' East 207.2 feet; thence South 51° 36' East 273.5 feet; thence South 27° 24' East 46.7 feet; thence South 63° 47' East 167.8 feet; thence North 5° 17' East 140.4 feet; thence North 29° 47' West 378.4 feet; thence North 25° 14' East 150.0 feet; thence North 76° 13' East 100.7 feet; thence South 78° 20' East 874.3 feet; thence North 1° 18' West to the North line of the S $\frac{1}{2}$ NE $\frac{1}{4}$ of said Section 31.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
