for the purpose of

irrigation of 116.9 acres
and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Jackson County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 16, at page 523; that the priority of the right thereby
confirmed dates from 1906:

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.34 cubic feet per second.

The point of diversion is located in the SEL N. Section 7. T. 38 S., R. 4 W., W.M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

24.9 acres in Lot 4 $(NE_{\pi}^{1} SW_{\pi}^{1})$ 17.4 acres in $SE_{\pi}^{1} SW_{\pi}^{1}$ 34.7 acres in Lot 3 $(NW_{\pi}^{1} SE_{\pi}^{1})$ 39.9 acres in $SW_{\pi}^{1} SE_{\pi}^{1}$ Section 12.

(Note. To the extent of 22 acres in Lot 4, 15 acres in $SE^{\frac{1}{4}}$ $SW^{\frac{1}{4}}$ and 4 acres in Lot 3, the foregoing right supplements the vested right allowed the predecessor to the claimant to the use of water from Williams Creek which is set out in the Rogue River decree on Page 26, Column 3, under Proof 823.

The supplemental right allowed herein is limited to use on the land to which it is appurtenant in an amount not exceeding 0.02 cubic foot per second of water for each acre irrigated during the irrigation season, and the quantity used from all sources shall not exceed 0.02 cubic foot per second per acre for each acre irrigated during the irrigation season.)

This certificate also confirms a change in point of diversion approved by an order of the State Engineer entered July 11, 1957 and recorded at page 194. Volume 9, Special Order Record pursuant to the provisions of ORS 540.510 to 540.530.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
