CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of Applegate Oregon State of has a right to the use of the waters of O'Brien and Sturgis Forks of Carberry Fork of Applegate River

for the purpose of

a tributary of Applegate River domestic, stock and irrigation of 110.0 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 16, at page 523; that the priority of the right thereby confirmed dates from 1857 for 0.30 c.f.s.; 1966 for 0.74 c.f.s.;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.04 cubic feet per second.

The point of diversion is located in the Sturgis Fork: SE4 ME4, Sec. 15, T. 40 S., R. 5 W., W.M.; O'Brian Fork: SE4 MV4, Sec. 12, T. 40 S., R. 5 W., W.M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

> 10.0 acres in NE 1 NE; 3.0 acres in Not Net 19.7 acres in SW NE 12.0 acres in SE NE 22.2 acres in NE SWE 16.4 acres in that part of SEA SWA described as follows:

Beginning at the NE corner of SE SW of Sec. 28. T. 38 S., R. 4 W., W.M., thence South 9 rods to the upper bank of the Hinkle Ditch; thence Southwesterly along said upper bank 78 rods; thence Northwesterly 31 rods to a laurel tree at the county road; thence along the county road Northeasterly 31 rods to the South line of the NE_1^2 SW_h^2 said Section; thence East 65 rods to the place of beginning.

> 26.7 acres in MW SEA Section 28, T. 38 S., R. 4 W., W.M.

(Note. To the extent of 1.8 acres in NEt NEt, 10 acres in Switch NEt, 12 acres in NE_1^4 NE_2^4 , 14 acres in NV_2^4 SE_3^4 , said Sec. 28, the foregoing right is supplemental to the vested rights allowed the claimant to the use of water from Thompson Creek which is set out in the Rogue River Decree on Page 34, Column 1, Proof 1023.

The supplemental right allowed herein is limited to use on the land to which it is appurtenant in an amount not exceeding 0.0094 cubic foot per second of water for each acre irrigated during the irrigation season, and the quantity used from all sources shall not exceed 0.143 cubic foot per second of water for each acre irrigated during the irrigation season.)

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
