CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRED SCHULZE

of Route 4, Box 685, Roseburg, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Lookingglass Creek

a tributary of South Umpqua River for the purpose of irrigation of 54.8 acres

under Permit No. 25902 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 17, 1958,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.68 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NE 1/4 and NW 1/4 SE 1/4, both as projected within Huntley DLC No. 40, Section 2, T. 28 S., R. 7 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of water in the South Umpqua River is 60.0 c.f.s. or more at its mouth,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.4 acre SW 1/4 NE 1/4
- 16.4 acres SE 1/4 NE 1/4
- 8.0 acres NE 1/4 SW 1/4
- 4.0 acres NE 1/4 SE 1/4
- 26.0 acres NW 1/4 SE 1/4

all as projected within Huntley DLC 40 Section 2 T. 28 S., R. 7 W., W. M.

This certificate is issued to confirm a change in place of use approved by an order of the State Engineer entered December 6, 1965, and supersedes certificate of water right heretofore issued to Fred Schulze and recorded at page 30942, Volume 22, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
