CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRANCIS M. & FRANCES M. KEETON

of Route 2, Box 62, Woodburn, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Butte Creek

a tributary of Pudding River for the purpose of irrigation of 33.9 acres

under Permit No. 18574 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 13, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.42 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 6 (NE $\frac{1}{4}$ SW $\frac{1}{4}$), Section 23, T. 5 S., R. 1 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.9 acres Lot 5 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)
 5.3 acres Lot 6 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)
 16.9 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within J. Magoon DLC 57
 0.1 acre NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within J. Magoon DLC 57
 1.3 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within J. Magoon DLC 57
 6.3 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within J. Magoon DLC 57
 0.1 acre NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within T. Chase DLC 46
 Section 23
 T. 5 S., R. 1 W., W. M.

This certificate is issued to correct and supersede the water right certificate recorded in State Record of Water Right Certificates, Volume 16, page 22311, so as to correctly locate the place of use.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
