CERTIFICATE OF WATER RIGHT

This Is to Certify, That F. E. AND MYRTLE I. MOLESWORTH

of Route 1, Box 27, Mosier, State of Oregon, has a right to the use of the waters of Carroll Spring

a tributary of _____ for the purpose of domestic use of one family and stock and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wasco County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 10, at page 48; that the priority of the right thereby confirmed dates from 1897;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second

The point of diversion is located in the Lot 4 (SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 7, T. 2 N., R. 12 E., W. M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

Domestic and Stock S $\frac{1}{2}$ Lot 4 (S $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$)
Section 7
T. 2 N., R. 12 E., W. M.

Certificate of water right issued to John M. Carroll and recorded at page 8133, Volume 8, State Record of Water Right Certificates, confirms the right to the use of water for domestic and stock in Lot _____ (SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 7, T. 2 N., R. 12 E., W. M. Subsequently, the right to the use of water appurtenant to the N $\frac{1}{2}$ Lot 4 (N $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 7, was canceled by order of the State Engineer entered August 12, 1965. This certificate is issued to confirm the right to the use of water for domestic and stock in the S $\frac{1}{2}$ Lot 4 (S $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 7, T. 2 N., R. 12 E., W. M. and supersedes the certificate heretofore issued to John M. Carroll.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
