CERTIFICATE OF WATER RIGHT

This Is to Certify. That DENNIS F. LEMONS

of Mt. Vernon Beech Creek , State of Oregon , has a right

to the use of the waters of

a tributary of John Day River irrigation of 80.0 acres

for the purpose of

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 15, at page 461; that the priority of the right thereby confirmed dates from 1873

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 cubic foot per second per acre irrigated to June 1 and 1/80 cubic foot per second per acre thereafter; further limited to one acre-foot per calendar month to June 1 and four acrefeet per acre during season April 1 to September 30, measured at point of diversion.

The point of diversion is located in the Beech Creek: N_{4}^{\perp} SE $\frac{1}{4}$, Section 21, T. 13 S., R. 30 E., W. M. Diversion point is located 80 feet South and 1840 feet West *(see below) A description of the place of use under the right, and to which such right is appurtenant, is as

20.0 acres in NE NW 40.0 acres in NW NW 12.0 acres in SW_{4}^{1} NW_{4}^{1} 8.0 acres in SE NW Section 28 T. 13 S., R. 30 E., W. M.

(NOTE: This land has a supplemental supply from Main John Day River with a priority of 1893 and a limitation not to exceed 1/40 cubic foot per second per acre irrigated from April 1 to September 30; further limited to one acre-foot per acre per calendar month to July 1 and 3/4 acre-foot per acre thereafter; total five acre-feet per acre for season, measured at point of diversion.)

This certificate is issued to confirm changes in points of diversion approved by orders of the State Engineer entered February 17, 1964 and May 27, 1963, and supersedes certificate of water right heretofore issued to J. W. Lemons and recorded at page 25468, Volume 17, State Record of Water Right Certificates.

*from the E_4^1 corner Section 28. John Day River: NE_4^1 NE_4^1 , Section 25, T. 13 S., R. 30 E., W. M. Diversion point is located 600 feet South and 1810 feet East from the MV corner, Section 25.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
