CERTIFICATE OF WATER RIGHT

of Route 2, Box 292, Dayton 9711h, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Yamhill River

for the purpose of

irrigation of 24.5 acres under Permit No. 11865 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 14, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.31 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW1 NW1 as projected within Hanna DLC LLL, Section 17, T. L S., R. 3 W., W. M. Diversion point located 50 feet East from the SW Corner, DLC LLL.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Commencing at a stone at the N.E. corner of that tract of land conveyed by deed from A. P. Kempton and Helen Kempton his wife to Louis Howarth and Anna C. Howarth, his wife and recorded in Book 82, page 340 deed records of Yamhill County, Oregon and running thence S. 27° W. along the Easterly line of aforesaid Howarth tract, said line being also the Easterly line of the Franklin Martin D.L.C. #45, a distance of 2007 feet to a point on the North Bank of the Yamhill River which is the S. E. corner and true beginning point of the land herein described; Running thence from said true beginning point N. 27° E. 908.55 feet to an iron pipe which is S. 27° W. 1098.15 feet from the N.E. corner of the

Certificate of water right issued to Joel W. Stewart and recorded at page 15127, Volume 12, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 24.5 acres. Subsequently, the right to the use of water appurtenant to 6.6 acres was canceled by order of the State Engineer entered June 17, 1963. This certificate is issued to confirm the remaining right to the use of water for irrigation and to confirm a change in point of diversion approved by an order of the State Engineer entered June 21, 1963, and supersedes the certificate heretofore issued to Joel W. Stewart.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of

use herein described.
