under Permit No. U-690 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 29, 1954

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.21 cubic feet per second from Well No. 3; 0.80 cubic foot per second from Well No. h

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the No. 3 - SW1 SW1, Section 34; No. 4 - SW1 NE1,
Section 33; T. 26 S., R. 15 E., W. M. Well No. 3 is located North 80 feet and
East 50 feet from SW Corner, Section 34. Well No. 4 is located North *(See Below)
The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited
to a diversion of not to exceed 3 acre feet per acre for each acre irrigated
during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
