or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Runoff NE 1/4 NW 1/4, Swale SE 1/4 NW 1/4, Section 7, T. 40 S., R. 19 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year and the right allowed herein for appropriation of runoff from NW 1/4 NW 1/4 of Section 7, T. 40 S., R. 19 E., W. M. shall be limited to the water available at the point of diversion, and shall not carry with it the right to compel the continuance of the waste water, and is subject to the terms and conditions of an order entered at pages 82 to 85, Volume 11, Special Order Record of the State Engineer, *(see below) and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Runoff NE $\frac{1}{4}$ NW $\frac{1}{4}$, Swale SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 7, T. 40 S., R. 19 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year and the right allowed herein for appropriation of runoff from NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 7, T. 40 S., R. 19 E., W. M. shall be limited to the water available at the point of diversion, and shall not carry with it the right to compel the continuance of the waste water, and is subject to the terms and conditions of an order entered at pages 82 to 85, Volume 11, Special Order Record of the State Engineer, *(see below) and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
