CERTIFICATE OF WATER RIGHT

This Is to Certify, That MATTIE JANE OSBORN

of Route 1, Box 67, Gervais, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Little Luckiamute River

a tributary of Willamette River for the purpose of irrigation of 96.2 acres and domestic use of one family

under Permit No. 27546 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 18, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.515 cubic foot per second, being 0.51 c.f.s. for irrigation and 0.005 c.f.s. for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Smith DLC 56, Section 8, T. 9 S., R. 5 W., W. M. Diversion point located 700 feet South and 2460 feet East from the NW Corner, Smith DLC 56.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

14.0 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
29.6 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$
9.6 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$
all as projected within Smith DLC 56

16.6 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
13.6 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
3.2 acres and Domestic SW $\frac{1}{4}$ NE $\frac{1}{4}$
9.6 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$
all as projected within Smith DLC 56
Section 17
T. 9 S., R. 5 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
