CERTIFICATE OF WATER RIGHT

This Is to Certify, That SUSAN J. MCAULIFFE

of Fort Klamath , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Fort Creek

a tributary of Wood River irrigation of 105.8 acres

for the purpose of

under Permit No. 26668 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 25, 1960

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.32 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW1 NW1, Section 26, T. 33 S., R. 7½ E., W. M. Diversion point located 940 feet South and 960 feet East from NW Corner, Section 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fiftieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Certificate of water right issued to J. L. and R. D. Helms and recorded at page 31066, Volume 23, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 118.1 acres. Subsequently, the right to the use of water appurtenant to 12.3 acres was canceled by order of the State Engineer entered April 22, 1966. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to J. L. & R. D. Helms.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of ruse herein described.
