CERTIFICATE OF WATER RIGHT

This Is to Certify, That W. R. HUTCHINSON

of Union State of Oregon, has a right
to the use of the waters of Catherine Creek and Ladd Creek (See Below*)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8, at page 1; that the priority of the right thereby confirmed dates from (See Below*)

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed Three acre feet per acre in any irrigation season diverted at a rate of not to exceed one-fortieth of cubic foot per second per acre;

Certificate of water right issued to W. R. Hutchinson and recorded at page 6394, Volume 6, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 760.0 acres. Subsequently, the point of diversion for the irrigation of 320.0 acres was transferred by order of the State Engineer entered July 23, 1964. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to W. R. Hutchinson.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
