**CERTIFICATE OF WATER RIGHT**

**This Is To Certify, That** ROBERT F. AND JEAN M. LEPSCHAT

of Route 1, Box 30, Forest Grove, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River a tributary of Willamette River for the purpose of irrigation of 13.0 acres under Permit No. 20098 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 6, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.163 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within R. F. Tupper DLC No. 42, Section 13, T. 1 S., R. 4 W., W. M. Diversion point located 750 feet West and 950 feet North from the SE Corner DLC 42.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.6 acre SE $\frac{1}{4}$  SE $\frac{1}{4}$   
as projected within R. F. Tupper DLC 42  
Section 13  
6.0 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
6.4 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$   
both as projected within R. F. Tupper DLC 42  
Section 24  
T. 1 S., R. 4 W., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

lying in the SE cor. of the Robert F. Tupper DLC in Secs. 13 & 24, T. 1 S., R. 4 W., W. M., and east of the Tualatin R. and more particularly described as follows: Commencing at a point in the center of said R. on the S. side of said Tupper Claim in Sec. 24, T. 1 S., R. 4 W., W. M., and running thence E. 25 chs. to the SE Cor. of said Claim on the W. line of the W. O. Gibson Claim, thence N. 23° 15' W. on the W. line of said Gibson Claim to the center of the said Tualatin R., thence up the channel of said river to the place of beginning.

This certificate is issued so as to correctly show the location of place of use and supersedes certificate of water right heretofore issued to Mrs. Virginia Bridges and recorded at page 20357, Volume 15, State Record of Water Right Certificates.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
