## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That CALVIN B. & BILLIE J. McCOWAN

of Route 3, Box 86, Scio , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Orabtree Creek

a tributary of S. Santiam River irrigation of 10.8 acres

for the purpose of

under Permit No. 19651 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 18, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0. It cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (SE4 SE4), Section 27, Lot 2 (NW4 NE4), Section 34, T. 10 S., R. 2 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.8 acres Lot 2 (NW4 NE4)
Section 34
T. 10 S., R. 2 W., W. M.

Land on which water is to be used is part of that described as follows: The following described real property situated in the County of Linn & State of Oregon, to-wit:

Lot 1 of Sec. 3h; ALSO, all of Lot 2 of Sec. 3h, EXCEPT 10 acres off from the N. side of said Lot 2, all in T. 10 S., R. 2 W., W. M.

Certificate of water right issued to Gary Vorderstrasse and recorded at page 22763, Volume 16, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 19.7 acres. Subsequently, a right to the use of water for irrigation of 8.9 acres was canceled by order of the State Engineer entered July 18, 1966. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Gary Vorderstrasse.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
